## A Letter from our WMHA President

Hello Whispering Meadows,

I am excited to be moving towards warmer weather and longer days of sun. With that comes increased use of our common areas and neighborhood streets. Spring is always a great time to witness our friendly and welcoming subdivision.

Your Board meets monthly to address Association business. All questions and comments which come to the Board get discussed at these meetings. Any decisions are communicated back to the resident. We were excited to hold our first Annual Board Meeting (open to the entire membership) on March 3, 2021 at the Novi Civic Center. COVID constraints forced us to delay this meeting by a month or so. A Facebook Live option was offered. We are aware the audio was inconsistent which we will address. The agenda and meeting video are still available on our Association Facebook page.

I would like to highlight a couple key points I addressed at the annual meeting. First, since our Board is relatively new, we wanted to move forward accurately and consistently with administering our responsibilities as they are defined by the CC&Rs and By-Laws. We found some of the language to be outdated and in some cases unclear. We sought the advice from the Law Attorneys Makower, Abbate, Guerra, Wegner and Vollmer. During their discovery it was determined although the 2010 CC&Rs had been rewritten, publicly discussed, and supported by the membership and the Board, the formal submission lacked the required 51% of voting members' signatures. As a result, with the help of the attorneys we are updating the language of our CC&Rs and we will bring them to membership for discussion and eventually a vote. Second, several of our members have complained about the Canada Geese population, specifically their droppings. With the increased use of our common areas, playground and Food Truck stations, the dropping have not only become a nuisance, but a health and safety issue. We have hired a company, Goose Busters, who is licensed by the State of Michigan DNR, to humanely relocate and reduce our resident and migratory geese population. They will use trained Border Collies, so you may see them throughout the subdivision.

2021 dues invoices were mailed out on February 1<sup>st</sup> with a March 1<sup>st</sup> due date. 263 out of 338 homeowners (77.81%) have paid their 2021 dues. The second dues reminder will be mailed out on April 15<sup>th</sup> with a \$5 late fee added. We have seven residents who have one year (2020) in back dues. Paying on time reduces costs for the Association and allows us to pay for common services.

- There were 3 phases in our subdivision.

- There were at least 3 builders: Kaufman-Brode, Binder and Pink.
- In 1978, a 4-bedroom colonial was being built for \$75,000 \$80,000 depending on the lot premium.
